Auburn City Council regular meeting was held on August 8. 2022 in City Hall. Mayor Richard Heim called the meeting to order at 6:00 pm with a roll call vote as following; Jane Barto, Linda Rath, Nick Meister, Robert Theulen, and Deb Ludwig.

A motion was made by Councilor Theulen and seconded by Councilor Meister approving the consent agenda including agenda, minutes from the July 12 ,2022 council meeting, approval of claims, Sheriff's report, and payroll. The motion was duly put to a vote of the Council. Ayes: Rath, Meister, Theulen, and Ludwig. Nays: Barto. Motion Carried.

A motion was made by Councilor Meister and seconded by Councilor Rath approving building permit 22-02. The motion was duly put to a vote of the Council. Ayes: Rath, Meister, Barto, Theulen, and Ludwig. Nays: None. Motion Carried.

A motion was made by Councilor Barto and seconded by Councilor Theulen that the City of Auburn, based upon the certified lab results paid for by the City of Auburn and conducted by the City's Engineer must refuse the Yetter Locker's request to relocate to Auburn due the following facts:

- Auburn's lagoon is designed to handle residential use only and relies on a natural, seasonal process of breaking down solids, rather than adding chemicals and aeration methods that is required to break down "hot waste" specifically blood and other animal processing byproducts.
- The DNR (Department of Natural Resources) will hold the City of Auburn solely responsible for any sewage discharge violations including penalties and fines. The City Engineer has estimated that modifications necessary to keep the lagoon in compliance could cost at a minimum \$350,000 to rebuild an aeration and chemical additives system.
- The City Engineer's test samples taken in July indicate that at Yetter Locker's current processing rate Auburn's lagoon would be near capacity effectively capping Auburn's residential and business growth.

The motion was duly put to a roll call vote of the Council. Ayes: Theulen, and Barto. Nays: Meister, Rath, and Ludwig. Motion fails.

City Council discussed the City's Hazzard Mitigation Plan and Emergency Response Plan.

A motion was made by Councilor Barto and seconded by Councilor Meister to table setting a public meeting date to discuss the use of city property south of town until a decision can be made regarding Yetter Locker. The motion was duly put to a vote of the Council. Ayes: Theulen, Meister, Rath, Barto, and Ludwig. Nays: none. Motion carried.

Resolution 22-24 authorizing and directing transfer of twenty-six thousand one hundred and seventeen dollars and sixty eight cents (\$26,117.68) from the sewer fund to the sewer sinking fund and twenty thousand and one hundred dollars (\$20,100.00) from water fund to water sinking fund was offered by Councilor Theulen and seconded by Councilor Meister. The Motion duly put to a roll call vote of the City Council. Ayes: Ludwig, Theulen, Rath, Barto, and Meister. Nays: none. Whereupon the Mayor declared the motion duly carried and Resolution 22-23 duly adopted.

A motion was made by Councilor Barto and seconded by Councilor Theulen to hire someone to trim the trees on the cityscape located on Pine St. The motion was duly put to a vote of the Council. Ayes: Ludwig, Barto, Rath, Meister and Theulen. Nays: none. Motion carried. Councilor Barto will oversee the tree trimming project and report back to the city council.
